The Milwaukee Youth Sports Authority does not fund professional staff and does not fund sports programs that are focused primarily on national tournaments and national competition. If you have not satisfactorily completed all final reports or owe money to the Milwaukee Youth Sports Authority, you may not apply for funding.

Completed grant application forms **with cover letters** are due at 12:00 noon, March 5, 2010. Emailed or faxed applications will not be considered. Submit **ONLY** the application form and cover letter; do not add a report cover, addendums, attachments, letters of support, or any other material. If you receive funding, we will ask for additional material as needed.
